150 YEAR CELEBRATION OF THE MORMON HANDCART PIONEERS

For SUP members who have traveled on I-80 in Nebraska over the past few years, you have probably noted the **Great Platte River Road Archway Monument**, a large museum near Kearney, Nebraska dedicated to the Nebraska trails through the years. Part of the museum arches over the freeway thus assuring it will be seen by travelers. The museum has many rooms of exhibits showing trails from Indian times, pioneer migrations, state highways and finally federal interstates. On June 2 and 3, 2006, a special celebration of the Mormon Pioneer Handcart Companies will be held at the Archway including a reenactment of the handcart expedition. (See <http://www.archway.org>)

On Friday, February 17, two lectures will be presented in Salt Lake City by **Ms. Ronnie O'Brien**, Director of the Archway Trails Center in Nebraska. She will take an in-depth look at a micro-section of the Mormon Trail in central Nebraska during the 1850-1860 Period. The first lecture will be from Noon to 2:00 p.m. at the State Historical Society, 300 Rio Grande, Zepher Room. The second lecture will be at 7:00 p.m. at This is the Place Heritage Park, Visitor's Center. The SUP is one of the sponsors of these lectures.

Sevier Valley The 5th Grade Essay Contest in Koosharem and Richfield attracted over fifty students. Awards were made at the January chapter dinner meeting. Wells Fargo assisted in the financial support of this contest.
