Speakers at 2012 Symposium Testify of Joseph Smith as a Prophet and a "Normal Man"

The 2012 Sons of Utah Pioneers annual Symposium took place at National Headquarters on Saturday, May 12. It was a very successful event based on both the rewarding content we heard from the five speakers, as well as how smoothly the proceedings were carried out. The theme of the Symposium was "Joseph Smith, Prophet of the Restoration." President-elect **David Wirthlin** was responsible for organizing and bringing the symposium to completion.

Four speakers gave presentations in the afternoon, speaking to audiences gathered in both the upper and lower meeting rooms of the Headquarters building. Introductions of the speakers and subjects were made by former National President **Grant Barton** on the lower level, and **Mary Ellen Elggren** in the upstairs meeting.

The first session included **Jeffrey N. Walker**, associate managing editor of *The Joseph Smith Papers*, and co-editor of the *Papers'* Legal and Business Records series. His background in the study and practice of law prepared him well for his subject, which was "Joseph Smith and the Law." He

focused his comments for the Symposium on the circumstances surrounding the creation and demise of the Kirtland Safety Society. This is a subject little understood by most Latter-day Saints, and one that is often referred to by critics of the Prophet as evidence of his weaknesses. After hearing this detailed and well-researched presentation, attendees could see beyond the generalizations and distortions of the critics, and understand the rise and fall of the bank in the important context of the times. It was pointed out, among many important and overlooked facts, that every one of the more than 1600 banks in the U.S. failed either briefly or permanently during the Panic of 1837. Bro. Walker also explained how the failure of the Kirtland bank led to the Kirtland Temple coming into the hands of men who eventually were among the founders of the Reorganized Church (now the Community of Christ).

Also speaking in the first session was **Karen Lynn Davidson**, co-editor of volumes One and Two of the Histories series of *The Joseph Smith Papers*. This well-qualified scholar, who holds degrees from BYU and her PhD from USC, spoke on "How a Renegade Historian Can Help Us Appreciate Joseph Smith." Her unusual title refers to the writers of the contemporary histories of the Church, and in particular to the history written at the request of the Prophet by John Whitmer. She presented detailed facts and insights into those histories which will soon be available in the published *Papers* volumes. One of her last anecdotes, summarized imperfectly by this writer, was enlightening and to a degree inspiring: She explained how John Whitmer had begun his history as a leader in the Church, but continued it after the death of the Prophet Joseph from outside the Church. He concluded eleven chapters of the sometimes critical and negative history, but at that conclusion he added a surprising and positive testimony of the Prophet and what John had experienced during his time in the Church. A few months passed after he said he had finished the history, and then he began again and added two more very angry chapters. Sis Davidson explained that he even went back and crossed out that testimony from his first conclusion. She pointed out that it is not known what happened during the three months between the first conclusion and the writing of the last two chapters, but apparently something happened. Perhaps some input from John's brother David contributed, as David was very angry with the Church and had thought that he himself might have been a candidate to replace Joseph. Then Sis. Davidson made a poignant observation that was remarkable. She said that there were many ways John could have crossed out the testimony he had written so that no one else could have been able to read it. But rather than blot it out permanently, he simply drew a "thin line" through it so that it remained in the document quite readable. We are left to imagine what those small details might have meant about John's true feelings.

In the second session, the next speaker was **Ronald O. Barney**, co-editor of the *Papers'* Documents series, executive producer of *The Papers* television documentary series, and an author of three books and many articles on Mormon History. His subject was "Joseph Smith, Then and Now." The key phrase from his presentation was "This man [Joseph Smith] is who we have said he is, all along." He also added, "There are just so many unexplainable things..." He explained during the beginnings of The Joseph Smith Papers research, which was funded by a generous gift from **Larry H. Miller**, that Elder Dallin Oaks had advised the editors that the Church wanted the research to be so thorough and accurate that the results would "be bullet-proof." Bro. Barney excerpted many testimonies by contemporaries and later scholars of Joseph Smith, most of whom were not in the Church, and showed clearly that when the research is done objectively, "We [The LDS Church, its members, and the scholars themselves] are not afraid of Joseph Smith." The testifiers he presented included William Clayton, Millen Atwood, John Needham, George Washington Taggart, John M. Bernhisel, Peter Burnett, John Reynolds, Josiah Quincy, Harold Bloom, Dr. Aziz S. Atiya and Dr. Wayne Hudson, among others. It was an inspiring and enjoyable session.

Also in the second session was Ronald K. Esplin, the general editor along with Dean C. Jesse and Richard L. Bushman, of *The Joseph Smith* Papers. Bro. Esplin's topic was "How Joseph Learned and Fulfilled His Mission." R. Scott Lloyd, writer for the Deseret News, summarized Esplin's message in this way: "Revelation from God was the dynamic that gave Joseph Smith his success." The first anecdote related by Bro. Esplin was from well-known historian Robert V. Remini, who has studied and written extensively about Jacksonian America, and who is also a

Joseph Smith biographer. Renmini asserted that, while he was not a believer that Joseph Smith was a prophet in the manner that Mormons believe, it is "beyond him" how one man alone without divine help could have accomplished all that Joseph Smith did. Other quotes used by Esplin to illustrate his message included David McCullough, "We must understand the past," and Pres. Gordon B. Hinckley, "If we want to stay on the track the Lord has put us on, we must know our history."

The evening dinner was wonderful, again successfully catered by Bro. and Sis. Dil Strasser. Music was provided by Jessica and Ben Smith, a niece and nephew of President-elect David Wirthlin, along with Amy Funk, a friend of those young people, who sang two duets, "The Prayer," and a folksong from a French poem called "Dirait-on." After dinner we were very pleased to hear Elder Marlin K. Jensen, retiring member of the First Quorum of the Seventy and Church Historian. With regards to his coming Emeritus status, one of Elder Jensen's more amusing comments was, "... unless my age discrimination lawsuit comes through!"

Again quoting from the notes of Scott Lloyd of the Deseret News, Elder Jensen said that "I'm interested in the relationship between what we know and what we do. That transfer of knowledge



to behavior is important..." It isn't enough to just accumulate knowledge and information, "it has to mean something in our lives."

Speaking about Joseph Smith as a man as well as a prophet, Elder Jensen also said, "It is encouraging to me that in addition to being one of the truly noble and great souls of all time, there was a normalness about Joseph... That's pretty... heartening to those of us who go through life in an ordinary way. It gives me hope, because most of the time I'm acting as a pretty normal person."

SUMMARY OF THE SYMPOSIUM

It is impossible to do full justice to the five outstanding presentations we heard at the 2012 Symposium. The messages were not only highly informative, but truly inspiring and testimony building. It is encouraging that these scholars and leaders who have dug so deeply into the original documents of the Restoration are still so enthusiastic about their work and have such active testimonies not only of the whole of the Joseph Smith story, but also of the details and fine points. They see

clearly and are able to communicate to their audiences that indeed we have nothing to fear from the truth about Joseph Smith. It is regrettable there were not 1,000 people present to hear these speakers so that their themes and testimonies could be spread even more widely among our families and friends and associates. Thanks to **President Richard Christiansen**, the office staff at Headquarters, and all of the National officers who brought this event to a successful conclusion by their planning and hard work.

BRIGHAM YOUNG CHAPTER (Provo, Utah) – On Thursday, April 19, 2012, Elder Carl B. Pratt (below), Emeritus Member of the



First Quorum of the Seventy, spoke to members of the Brigham Young Chapter of the Sons of Utah Pioneers. He talked for a short time on the Church in Asia, then spent most of his time in telling us about the history of the Church in South America and especially about his experience as the Church's legal counsel there. The growth of the church in Asia since the

Korean War has been phenomenal, but not as rapid as in South America. Near the end of his service as a member of the First Quorum of the Seventy, Elder Pratt was called as a counselor in the Asia Area Presidency. Over the past few years, the church has organized stakes in a number of Asian Countries including Japan, Korea, Taiwan, Hong Kong, and elsewhere. In June 2009, the Church organized its first stake in Mongolia where there are more than 10,000 members. At long

last, India will get its first stake, the Hyderabad India District will become a stake in May 2012.

Chris played the flute, and also accompanied Elaine on the piano.



One of the stories was about a forbearer named Mary who joined the church, went to Nauvoo and married into the Richards family. When her husband left for a mission to England, he told her to write a journal, and this she faithfully did up to the day he returned. As he left to travel east to England, she started her journey west with the pioneers.

Another story was about Israel Barlow who was a "tithing" worker on the Nauvoo temple. He was very good with horses and hauled stone from the quarry to the temple. He was close to the Prophet and was told by him to buy a whip. Israel had never used a whip on his team before and could not understand why he should buy one. However, he followed the counsel of the prophet and within a short time was required to use the whip to stop his team from backing over the steep edge of the quarry. It was a most interesting program.

LEHI CHAPTER (Lehi, Utah) – The chapter's April meeting featured National SUP President **Richard Christiansen**. He spoke to the group about the headquarters building in Salt Lake City, and its on-going importance and usefulness

HISTORY OF THE LDS CHURCH IN SOUTH AMERICA

From talk given by Elder Carl B Pratt at the Brigham Young Chapter dinner meeting on April 19, 2012 (see page 3)

Elder Parley P. Pratt of the Quorum of the Twelve Apostles is Elder Pratt's great-great grandfather. Parley P. Pratt served in South America as a missionary in Chile in 1851-52. He actually wrote a pamphlet in Spanish about the mission of the church. After Elder Parley Pratt left Chile, the church did not grow very much in Latin America for more than 100

years, with the exception of the Mormon colonies in Mexico.

In December 1925, Elder Melvin J. Ballard of the Quorum of the Twelve together with Rey L. Pratt of the First Council of the Seventy and Rulon S. Wells traveled to Buenos Aires, Argentina, where they held a church service. Elder Ballard dedicated Argentina and all of South America for the preaching of the gospel. Later in a talk, Elder Ballard likened the growth of the church to the growth of a tiny acorn. It grew slowly at first, then very rapidly. Shortly after Elder Ballard dedicated South America for the preaching of the gospel, the Church organized a mission called the South American Mission which functioned principally in Argentina and Brazil. Reinhold Stoof, a German immigrant to the United States, was called as mission president. The mission was designed to preach the gospel to German immigrants rather than to Hispanic Latin Americans.

The missionaries began to have tremendous success in South America beginning in the 1960s. During this period, people in Latin America began to leave the Catholic Church which had previously been very influential there. The Church moved into the countries of northern South America with the creation of the Andes Mission in Peru and Chile in 1959. The first units of the Church were established in Bolivia in 1964; in Ecuador in 1965; and in Colombia and Venezuela in 1966. Today many of the LDS missionaries in South America are local members who have been strengthened and prepared for service and leadership by attending seminary and institute programs of the Church Educational System.

"Faith in Every Footstep" Grave Markers

In 1997, a Church committee created a marker to be attached to the graves of Pioneers who arrived in the valley prior to the coming of the railroad. These were sold to anyone who wanted to attach one to the grave of his or her ancestor, in commemoration of the sesquicentennial of the arrival of the Pioneers in 1847.

For some time the markers have not been available, and we (the SUP) have had frequent requests as to how to get them. The National office of the SUP has made arrangements to have a number of them manufactured and are making them available to members or others who wish to honor their ancestors by attaching one to his or her grave marker.


The markers are 2 ½ inches by 3 ½ inches of very durable metal. Those who attached them in 1997 say they have not deteriorated from weather.
