## **PRESIDENT'S MESSAGE**

### Personal Histories as Scriptures

Why does SUP ask all members to submit their life history, then add histories of ancestors and memorialize them? The main mission of SUP is to turn our hearts to our fathers and their hearts to us-- it is to come to the knowledge of our fathers (Mrn. 7:5). One of the best ways to do this is through submitting histories and memorializing ancestors. Histories when written by the Spirit serve as scriptures to us. "And whatsoever they shall speak when moved upon by the Holy Ghost shall be scripture" (D&C 68:4). Thus, as we seek the Spirit in writing our journals and histories they become as scriptures for us and our posterity. In one sense, that is what the Book of Mormon and other scriptures are, brief histories written by the Spirit for the benefit of later generations to show the dealings of God with his people.



The scriptures teach us that one important purpose of the Urim & Thummim, seers and scriptures is to reveal the sins of the wicked. Elder Todd Christofferson in the last conferences asked why is it that we are to know the sins of the wicked, and then answered by saying, "To warn us." We all have had ancestors who disappointed us or fell by the way side somewhere along the way. Seeing what happened to my ancestors who turned from the covenant gives me greater determination to avoid the way they went. Seeing what happened to those who kept their covenants and were strong in the faith gives me power to follow the faithful.

One of my great-grandmothers joined the Church in Wales with her family, went through many trials to immigrate across the ocean, they stopped in Pennsylvania long enough to earn funds to bring the rest of the family, only to have her father get discouraged while working in the Pennsylvania mines, turned to drinking and had to be left there to die. This great-grandmother came on across the plains, married in the covenant in plural marriage in the Salt Lake Valley, faithfully endured great trials helping to settle about 5 settlements in Idaho and Utah, only thereafter to leave her husband, my great grandfather David Leonard Savage, and most of her children, to run off to California to marry an old flame. The rest of the family remained true and faithful to their covenants and left a great posterity who love and honor them. But this great grandmother got lost into the world and died young at the age of 39.

So I am very grateful to SUP for how it teaches us the importance of writing the histories of all our ancestors. From all this I learned that we are to come to know our ancestors who forsook the covenant as well as these who lived it to the end-- and that my salvation depends on my gaining this knowledge. Now we see the great need to fulfill the commandment to come to a knowledge of all our fathers, to see and understand the whole picture-- the rest of the story.

In this last conference Elder Bednar explained that it is through the Spirit of Elijah that we search out and document our ancestors histories, and that love of, and gratitude for, our ancestors will increase-- all a

vital part of the work of Salvation. May the Lord bless us in the Spirit of Elijah, that we may more fully come to the knowledge of, and learn to love and become acquainted with all our ancestors by writing histories, submitting those histories to the SUP library and memorializing them in the SUP hall of fame--for both the faithful and the wayward.

**BOX ELDER CHAPTER** (Brigham City, Utah) The Chapter is sponsoring an event at the Brigham City Tabernacle on October 21. The actor **Travis Eberhard** (below), who played

**BRIGHAM YOUNG CHAPTER** (Provo, Utah) The Chapter gave ten \$1,000 scholarships in May to high school seniors in the Provo area. \$25 Essay Awards were also made to three elementary students for their writing

The Brigham Young Chapter's **Pioneer Village** was formally dedicated by National SUP **President La Mar Adams** on August 18, 2011. In 2010 the Village hosted 20-30 visitors on a shift, but after the continuing renovations and improvements, the site now enjoys 30-50 visitors on an evening. **CEDAR CITY CHAPTER** (Cedar City, Utah) On June 24, **Leon Matheson** of the Cedar City Chapter was involved in the dedication of a monument south of Black Ridge at the Snowfield exit on I-15. The monument remembers two Franciscan Priests, Atanasio Dominguez and Silvestre Velez de Escalante

were sent by the governor of New Mexico to find a trail to California. Their travels became part of the Old Spanish Trail. Other contributors to the monument besides Leon and Barbara Matheson were the Fort Harmony Historical Society, Washington and Iron County Historical Societies and the Old Spanish Trail Association.

### **HURRICANE VALLEY CHAPTER**

(Hurricane, Utah) In August, the Chapter heard **Elder V. Dallas Merrill**, emeritus member of the Seventy, speak about his experiences in contacting the Catholic Church leaders in the Vatican on behalf of the LDS Church.

The Chapter invited neighboring Cotton Mission S.U.P. members to attend, and there were more than 150 present.



Elder Merrill's message was very informative, as he explained to the attendees that the members of the Vatican had never met a leader of the LDS Church, and "they were intrigued with us." That first meeting brought other meetings, and now there is a cordiality between us. The Vatican has even relaxed a rule that would not allow anyone from the LDS to have access to their archives, and are allowing Brigham Young University to digitize many ancient records.

**JORDAN RIVER TEMPLE CHAPTER** (Salt Lake Valley Southwest, Utah). In the City Council Meeting held August 24<sup>th</sup>, West Jordan City approved the Chapter's request to place a **monument** on City property at 2200 West and 7800 South in West Jordan. This memorial will recognize two men who had businesses in that vicinity prior to 1900. Funding to cover the

nearly \$1,000 cost of the project will come from donations from descendants of the two men and from members of the Jordan River Temple Chapter. With this approval, steps will proceed immediately so that the project can be completed well before inclement weather comes. The vendor who will inscribe the stone and install it at the site estimates that it will be done within three to four weeks.

September's meeting featured **Russ Felt** and **Mike Moon** who recounted the coming of Johnson's Army to Utah, including the various places they camped before coming to Camp Floyd. They also discussed the Soldiers and officers and their feelings about the Mormons.

### **MAPLE MOUNTAIN CHAPTER (Mapleton, Utah)**

There were 44 members and visitors who enjoyed the Sept. 22nd chapter dinner meeting held at the LDS chapel at 10th S. & Hwy 89 at 6:30 PM. B. Ray Anderson gave a very interesting vignette about his great grandmother whose parents passed away while pioneering west, so she walked all the way to the Valley as an orphan and where she was placed with another family by Brigham Young when she arrived in the valley. After the lovely dinner Jay Smith gave a PowerPoint presentation on the Church pioneering through Asia, a report of the growth of the Church in Asia. Pres. and Sis. Smith (below) gave interesting experiences about their


Kong, Laos, India, Thailand, Taiwan, Malaysia and Nepal. Of special interest was how rapid the Church is growing in these areas and in so many Asian countries. They showed photos of Hong Kong, one in 1950 with nearly barren country side, and the same area today with hundreds of high rise buildings, including several LDS tall buildings, the temple, office buildings, etc.

The next dinner meeting is scheduled for Thurs. night Oct. 27 with Andrew Ehat giving his very interesting PowerPoint presentation on "Joseph's Endowment Pioneering, from Kirtland to Nauvoo."

**MESA CHAPTER** (Mesa, Arizona) The September dinner program included music by **Debbie Coon and Jeff Montgomery**. The speaker for the evening was **Bill Frost**.

**MILLS CHAPTER** (Southwest Salt Lake City, Utah) In September, **David Wirthlin**, former chapter president and newly elected National President-elect for 2012, spoke to the chapter about the experiences he and his wife, Anne, had while serving recently as President and matron of the Nauvoo Temple. He talked about how President Hinckley directed the beginning of the long awaited rebuilding of the temple, and the blessings received by those who have come through the temple doors to give service or for their own blessings.

**OGDEN PIONEER CHAPTER** (Ogden, Utah) In 1878, seven Catholic Sisters of the Holy Cross Ministries established the Sacred Heart Academy in Ogden. In 1883 the Academy moved to its permanent location on 25th Street, where it continued to operate for 55 years until 1938. As many as 600 students were boarded at the




Academy, and up to 21 Sisters staffed the institution. The building was eventually demolished in 1961 to make way for the new Utah State Office Building.

In September, the Ogden Pioneer Chapter dedicated a bronze plaque (left) to memorialize the pioneers in education that established the Academy. Dr. Paul Southwick, chairman of the Monuments Committee for the Chapter, and other S.U.P. leaders including Stewart Radmall, National

Monuments Director, and Robert DeBoer, Area Vice President, attended the dedication of the marker placed inside the State Office Building. Said Southwick, "We want to honor all of the pioneers in our area and really want to accentuate the characteristics of the people and places that were important to our history."

**POCATELLO CHAPTER** (Pocatello, Idaho) This new chapter was chartered on June 16, 2011, with **La Mar Adams, Dick Christiansen, Dil Strasser**, representing the Nation Association, and **Jerry Glenn**, Area Vice President, all present. New officers (below) are



**Ed Holt**, President; **Thayne Smedley**, President-elect; **Gerald Homer**, Program chair; **Joel Hardy**, Membership chair; and **Robert Tomlinson**, Secretary. At their August meeting, **Keith Hamilton** spoke to the group on

"Contributions of Black Members to Our Pioneer Heritage."

Hamilton is an attorney in South Jordan, Utah, and former member of the Utah Board of Pardons and Parole. He is a convert to the LDS Church, and was the first black person to hold a cabinet level position in Utah state government, as Chairman of the Parole Board.

**SALT LAKE CHAPTER** (Salt Lake City, Utah) On September 1st the Salt Lake Chapter of SUP had the privilege of hearing directly from the talented team producing History of the Saints. **Glenn Rawson** (right), extraordinary story teller, and the 'face' of **The Joseph Smith Papers**, mesmerized our audience with inspirational and insightful details of the genesis and history of the self-funded **History of the Saints** project. The History of the Saints traces the migration of the Saints westward following the Prophet Joseph's martyrdom, and the many events that occurred subsequently.



**Dennis Lyman**, popular cinematographer of the JSP and History of the Saints, and **Bryant Bush**, editor, entertained and answered questions about their respective roles in these projects. At the

conclusion of their presentation they received a rare standing ovation, and the excitement in the audience was nearly palpable. Our guests happily stayed on to chat with chapter members until the lights were ready to be turned off and the building vacated. It was a remarkable, informative and inspirational evening. **SEVIER VALLEY CHAPTER** (Richfield, Utah) Congratulations to Sevier Valley Chapter member **Calvin Curtis**, who was honored as the Sevier County Cowboy of the Year over the Pioneer Day Weekend in Ogden, Utah, during the "National Day of the American Cowboy" celebration. Calvin was honored because he has made an outstanding contribution to the western heritage lifestyle and to the preservation of Utah's western and cowboy culture for future generations, and because he personifies courage, hard work honesty, integrity, and patriotism. Calvin is also being recognized as the Honorary Cowboy of the year at the Sevier County Fair ("Remember that's honorary not ornery").

At the August dinner meeting, the chapter met at the historic Fishlake Lodge, and then heard **Jo Callister** present a history of the Fishlake area.

The September meeting planned to enjoy a ride on the Heber Creeper on September 23, hopefully in time for the fall colors that are a couple of weeks late this year.

**TEMPLE FORK CHAPTER** (Logan, Utah) The September speaker was **Jay L. Nielson** (right), who served as Logan City Planner for ten years. He has had a 40-year



career in community planning all across the country. He spoke about the value of the grid system that Joseph Smith used as a basis for planning the city of Nauvoo, and which Brigham Young continued to use in many cities in Utah. While Jay was trained that the grid system was no longer appropriate in modern communities, he now believes that the grid system needs to be used in today's community planning.

One advantage of the grid system is that it is relatively easy to find your way around a grid-planned city. Several major cities started with a grid system, including Chicago, New York City, Phoenix, Ft. Collins, and parts of Washington D.C., as well as most cities in Utah. In 1966 the Plot of Zion, as Joseph Smith's plan was called, was given a National Planning Award for a system that presents well planned and culturally nurturing cities. The Plot of Zion doesn't solve all our problems today, things are more complicated than 150 years ago, but it is a preferred plan.

During a question and answer period, some interesting comments were made: Roundabouts are a very efficient way to move traffic, but they do take some time to learn to use. Four-way-stops improve safety, but do not help move traffic.

**UPPER SNAKE RIVER VALLEY** (Rexburg, Idaho) **The Fort Henry Monument** in St. Anthony, Idaho, was re-dedicated on September 5, 2011. The monument is located on the south bank of Henry's Fork of the Snake River on Bridge Street in St. Anthony.



The previous monument was deteriorating and the Upper Snake River Valley Chapter of the S.U.P., the Upper Snake River Valley Historical Society, and the City of St. Anthony grouped together to restore this monument. A completely new monument was erected and the plaque from the old monument was cleaned and reattached.

The historical caption on the original plaque reads: *"Fort Henry was built in the fall of 1810 by Captain Andrew Henry and his companions of the Missouri Fur Company, about five miles below here on the left bank of this stream (Henry's Fork of the Snake River). First buildings erected by Americans in the present state of Idaho, it was abandoned in the spring of 1811 but was occupied in October of that year by Wilson Price Hunt and the overland Astorians, who left their horses, built canoes and sought to continue their journey by water to Astoria. The water journey ended at Cauldron Linn on Snake River near the site of Milner Dam, the party proceeded on foot, arriving at Astoria Feb. 15, 1812."*



A new plaque (above) commemorating the restoration and the 200<sup>th</sup> Anniversary of the construction of the fort was placed on the new monument below the original brass plate.



## PROVO PIONEER VILLAGE UPDATE

This summer has been the best season yet for the Provo Pioneer Village. Some of the new changes included:


- An operational bathroom with real flush toilets. It is faced with logs and looks really good fitting in with the rest of the Village. It is a most welcome addition.
- The Haws cabin has been restored with new logs replacing the logs that were seriously deteriorated and major work on the interior plaster has also been done. The cabin was built in 1870 and it appears the plaster was put up shortly thereafter. The original lath was put on with square nails, which has been preserved.
- Brayden McKnight did his Eagle project, building a two-hole privy. He did a nice job, even making the hinges on the blacksmith forge. It is a major contribution to the Village.
- Our own Bill Giauque, a master gardener, planted a beautiful garden that is the envy of everyone who comes into the Village. It is now in production and the produce is marvelous. We have received numerous compliments on the garden; it makes the Village really come alive.
- We planted a variety of other trees and bushes throughout the Village also under the direction of Bill Giauque. They will continue to have a lasting impact on the Village.
- We put up a Sponsor Board in the building that also houses the blacksmith shop.
- We listed over 100 contributors to the Village since 2007. It is quite impressive to see the assistance we have received.
- Under the direction of Darold Francis, we put a coopering shop on display. Darold works in the shop demonstrating barrel-making when we have special events in the Village.
- We increased the number of descriptive labels and printed interactive games in addition to having developed a self-guided tour handout all to make the visitors' time in the Village more enjoyable and educational.
- We included more things in the store and more antiques for sale, all of which seems to attract the interest of the visitors. Members of the DUP have made aprons and bonnets and donated them to sell in the store.
- We expanded the number of docents and provided training for them to provide effective assistance to the visitors.
- We all had a wonderful time serving in the Village.



All of these efforts seem to be paying off. The number of visitors has substantially increased and their enthusiasm has been gratifying. We have never received such accolades as we are now receiving. In the words of one little girl, "This is a really special place." We have hosted family reunions, youth groups, Cub Scout pack meetings, Scout troops, family home evening groups, school groups and senior citizens. Last year when we had 20 or 30 visitors in a shift we thought it was great; now we are hosting 30 to 50 in an evening. You can be proud of the contributions you have made with your support and your hard work.

## MUSEUM PROJECT

### *Proposed Pony Express Museum*

Joe Nardone, former Executive Director of the Pony Express Trail Association, has spent a lifetime researching and collecting artifacts pertaining to the Pony Express. It is his desire to leave his vast collection to a secure facility close to professional researchers, interested youth, students, and everyday citizens. He has offered his collection to the National Society of the Sons of Utah Pioneers.

The collection consists of over 900 books, other publications, and historical artifacts. One of the artifacts is an original 1858 Bible presented to Alexander Majors, one of the Pony Express founders. There are only three of these Bibles known to exist in private hands. The other 15 are in public institutions. He has seven bronze statues of the Pony Express, including a model of one at "This is the Place Heritage Park," in Salt Lake City, as well as numerous works of art. To date he has 32 legal size file drawers full of Pony Express materials. There is also a collection of 1860-1861 microfilm of newspapers from New York City to San Francisco and a set of maps of the entire Pony Express route from St. Joseph Missouri to San Francisco, California.

The Sons of Utah Pioneers is proposing to modify their current headquarters facility in Salt Lake City to include an area that will house this collection, to be known as "The Joseph Nardoni Memorial Pony Express Library." The Salt Lake City/Provo population center is the largest population center close to the route between Omaha, Nebraska, and Sacramento, California, near the mid-point of the 1900 mile Pony Express route, and, thus, is the logical site for the Pony Express Collection.

## SUP 2012 HOLE-IN-THE-ROCK ADVENTURE TREK

(This trek is planned with the cooperation of the Hole-in-the-Rock Foundation.)

- Day 1 We will meet the bus at the National Headquarters Building in Salt Lake City, where we may  
Mon. leave vehicles if desired. We will make a stop at historical **Cove Fort**, then travel to Parowan  
May 14 and visit the **Parowan Meeting House/Museum**. We will also be treated to a **dutch oven dinner** there. Overnight in Cedar City.
- Day 2 Our first stop this morning will be a visit to the **Iron Mission Museum**, then we will drive  
Tue. through northern Arizona and southern Utah on our way to Page, AZ. On the way we will  
May 15 stop at **Pipe Spring National Monument**. As we travel we will learn more of the history of this area, and of the Hole-In-The-Rock expedition so we can be prepared for our visit there. **After arriving in Page you will have the option of making an excursion into one of the fascinating slot canyons, (extra cost - @\$30) or you may choose to go to the visitor center at Glen Canyon Dam and make the short hike to the spectacular overlook at Horseshoe Bend.** (If the weather and roads allow, we will have another option. That is to skip the museum and slot canyons and make a trip the the North Rim of the Grand Canyon on our way to Page.) Overnight in Page.
- Day 3 An early morning **flight** in smaller planes, where everyone will have a window seat, will  
Wed. take us over the Lake Powell area to **Rainbow Bridge** and the **Hole-in-the-Rock**. We should  
May 16 be able to see not only these two impressive sites, but also much of the trail leading to and from the Hole-in-the-Rock so we have a good perspective of the country these hardy pioneers traversed in filling their mission to the San Juan. After returning to Page, and getting some lunch, we will have a relaxing afternoon taking a **float trip** (smooth water!) from just below the dam to Lee's Ferry. This will take us through breathtaking scenery. We will return to Page for the night.
- Day 4 This will be a another enjoyable day, as we drive from Page to Bluff, Utah, looping down  
Thur. through some of the Navajo Reservation. On the way we will visit **Monument Valley**, where  
May 17 we will visit a historical museum and enjoy a Navajo Taco **lunch**. We will also see and learn about some of the historical landmarks and history of Monument Valley. We will then drive through Bluff and on to **Salvation Knoll**, which was significant in the Hole-in-the-Rock experience. Those who desire to may climb the bluff and see what some of those early pioneers saw as they searched for the goal they were seeking. We will also enjoy another **Dutch Oven Dinner** while in the area. We will then return to Bluff, and spend two nights there.
- Day 5 Our group will be divided today, with half the group visiting **San Juan Hill** and **River House**  
Fri. **Ruin**, while the other half tours the **Bluff Fort**, historic homes, and the cemetery. In the  
May 18 afternoon the groups will switch. **Those visiting San Juan Hill, etc. will be riding in SUV's and on ATV's. (Four Wheelers.) We will need to have at least three couples in each group who feel comfortable driving and riding a four-wheeler!** In the evening we will be treated to a **group meal** and fireside in the Bluff log meetinghouse, then return to our motel for the night.

Day 6 Our trip home will take us through Moab, Green River, and Price as we make our way back  
Sat. to Salt Lake City, and on to our own individual destinations. We will have a new under-  
May 19 standing and deeper appreciation of the price paid by these early pioneers to settle this part  
of Utah, as they filled their mission calls.

## “Faith in Every Footstep” Grave Markers

In 1997, a Church committee created a marker to be attached to the graves of Pioneers who arrived in the valley prior to the coming of the railroad. These were sold to anyone who wanted to attach one to the grave of his or her ancestor, in commemoration of the sesquicentennial of the arrival of the Pioneers in 1847.

For some time the markers have not been available, and we (the SUP) have had frequent requests as to how to get them. The National office of the SUP has made arrangements to have a number of them manufactured and are making them available to members or others who wish to honor their ancestors by attaching one to his or her grave marker.


The markers are 2 ½ inches by 3 ½ inches of very durable metal. Those who attached them in 1997 say they have not deteriorated from weather.
